The products must only be used in an environment that corresponds to their IP protection.



3.2 Product description

AdaptLine is a height-adjustable unit where you can mount a disability-friendly washbasin. AdaptLine has a convenient and compact design which makes it highly suitable for smaller bathrooms where space-saving solutions are required.

3.3 Intended use


The AdaptLine washbasins are available with manual height adjustment to better the use for wheelchair users and walking impaired patient. Height adjustment is done with the small crank. The height adjustment range is 20 cm / 7.8 in.

3.4 Intended operator

Reading and understanding this manual will be sufficient training for an intended operator. Children or patient are not considered intended operator.

3.6 Use

Height adjustment

The washbasin height can be adjusted by means of the flexible handle. The grey top cover must be dismounted first, however.

Then mount the flexible handle on the hexagonal shaft. Subsequently, the washbasin height is adjusted by turning the handle.





Caution!

When the unit is adjusted in height, it is possible to squeeze fingers between the cover and the unit.

Using flexible hand crank can position moving hand close to wall.



Note!

Be careful not to swing the crank into the mirror or tile on the wall. They can break.

3.7 Safety in use

- Ropox AdaptLine may only be used by persons who have read and understood these instructions.
- Always use the product in a manner excluding the risk of damage to persons or property. The person operating the Ropox AdaptLine is responsible for avoiding damage or injury.
- > Any modification which may influence the performance or construction of the product is not allowed.
- Installation, service, and repairs may only be carried out by qualified personnel.
- During inspection, service, or repairs any load must be removed from the unit.
- > Be aware of water splashing from the wash basin during use or adjusting the height. A wet floor will result in a slipping hazard.

3.8 Cleaning

During use, the product may get dirty. It is very important to clean the unit as described in these instructions.

Cleaning of unit

Ropox AdaptLine may be wiped with a wrung cloth with lukewarm water and a mild detergent. Do not use corrosive/grinding fluids or scouring sponges.

Disinfection may be done with household disinfectants.

Cleaning of washbasins

Wash the surfaces daily with water and wipe off with a dry cloth. Do not use detergents containing hard abrasives – e.g. steel wool, scouring powder, or sulphuric acid.

If the water has a high calcium content, calcareous deposits will often occur in the washbasin. These deposits should be removed at least once a week by using a detergent containing citric acid, acetic acid, or phosphoric acid. Leave the detergent to work for 5-10 minutes depending on the thickness of the deposits and clean thoroughly with a soft sponge.

Disinfection of the washbasin may be done with household disinfectants.

Note!



Do not use cleaning agents containing abrasive e.g. scouring powder, steel wool, scouring sponge.

This product is not designed to be sterilized, autoclaving and sterilization beyond normal cleaning is may possibly change the product safety and function.

4. Mounting instructions

4.1 Installation information

Construction

The wall must of a suitable material for screws and approved for wet rooms.

The grey-shaded area states the minimum area for reinforcement of the wall.

Load tested in accordance with DS/ISO 17966:2016, the max. user weight is:

Plumbing

The drain is Ø32 mm / 1.3 in.


The water supply ends with 2 (two) 90° stop valves with $\frac{1}{2}$ outside thread pointing downward.


All hoses for water and drain installations must be flexible to ensure free and unhindered adjustments within the height adjustment range of 70 - 90 cm / 27.5 - 35.5 in (the top of the washbasin).

For the purchase of adapters for connection to various standard installations, see the section "Connection adapters".

Note:

All dimensions are based on a washbasin height of 700 - 900mm / 27.5 - 35.5in above floor level. If a change of this height is required, the recommended dimensions must be changed accordingly.





5.2 Performance test


After one month
